I, THE UNDERSIGNED, DO HEREBY DECLARE THAT THE DRIVER AND CO-DRIVERS LISTED ON THIS ENTRY FORM POSSESS THE

STANDARD OF COMPETENCE NECESSARY AND ARE PHYSICALLY FIT FOR AN EVENT OF THIS TYPE FOR WHICH THIS ENTRY RELATES

AND THAT THE VEHICLE ENTERED IS TECHNICALLY LEGAL FOR ITS CLASS, AND SAFE FOR THIS EVENT.
